## **Objectives (5) to be included into the CISM European BP**

### **Objective 1**

To complete the European Calendar for the next year during the European Conference. This means that 100% of the events we (Europe) want to organize in the next year should be announced during the European Conference.

= to improve our planning system in terms of European Calendar, to have a stable calendar.
